Additional information	: (Dilution test data applicable to the ZDDP (zinc dithiophosphates) present in the mixture. A product with a concentration of 15.4% ZDDP was tested in an in vivo eye irritation study (OECD405). A slight one redness and chemosis could be seen after 24 hours, but were found to be complete reversible after 48 hours. No further signs of irritation were observed during the observation period of 7 days. These test data confirm that the mixture is not compliant the classification criteria for eye damage 1, H318; eye irritation 2, H319; skin irritation 2, H315 according to the CLP Regulation as a mixture with a concentration of <15% (weight percent) ZDDP contains.)
